On Jan 22 2025, the TRPA Governing Board approved Homewood's Master Plan Revision + Community Access Plan. These documents, as well as the discussion on public record, strengthen's the public's access to Homewood.

The TRPA also approved a permit to construct a gondola to replace Madden Chair. Conditions of that permit guarantee public access to that gondola.

KHP will continue monitoring this project to ensure public access is provided as promised.

I don't use the park, beach, buoys or go to the concerts in the park so why should I join? The TCPOA represents the neighborhood in many other ways. One is our cleanup day. When I first moved to Tahoma in the early 1980's it was a dump. Trash everywhere, abandoned cars and tires and building lots not cleaned up (a fire hazard). The roads were dirt and the plowing was substandard. In the past TCPOA has negotiated with county for paved roads and better plow service. The TCPOA has installed many of the fire hydrants in the neighborhood through your membership dues. Currently we have board members involved in Keep Homewood Public and another board member is working with the TCPUD on our new water system going into Tahoma, hoping to help keep the cost down to homeowners. If you like our clean safe neighborhood please consider joining for a low \$120.00 a year, a mere \$10.00 a month. We need your help and support, remember **"It Takes a Village!!!"**

Sugar Bear and Snowflake

Now is the Time of the Birth of the Baby Bears. Typically, they are all born between the middle of January and the middle of February.

Here at Tahoe, where about 100 to 150 bears try to den in crawl spaces---and many succeed---some cubs are born while their Mamas are wintering under a house or cabin. Once they are born it is illegal to evict them, obviously and thankfully.

The bear family will not leave the natal den until about mid or late April, so the human family above them has guests---welcome or not---sharing their home for about four months. During that time the bears, with fast growing and curious cubs, can cause a lot of damage to the water pipes, gas lines and heat duct-work etc. This is why the BEAR League preaches endlessly to our local homeowners to Secure Your Crawl Spaces Before a Bear Moves In.

The other downside to newborn cubs under a home is the fact that when they start to emerge in the spring they don't just suddenly come out one day and leave. They have to learn to run fast and climb trees before their Moms take them off into the big, dangerous world. This means the homeowner will have a family of very vulnerable bears right in the yard for several weeks.

The cubs need to practice climbing, learn how to run fast to the nearest tree when Mom tells them to, and stay up high until she calls them back down. Some properties are very safe and comfortable for the bears during this time, others are Not.

There needs to be a good tree very nearby and no dogs who run free in the area.

One year, a resident thought it would be wonderful to have a Mama Bear give birth under her home, so she welcomed her in November without thinking about the safety of the emerging cub in April. She had no close-by tree and her neighbors allowed their aggressive dog to chase wildlife. Within two days after the cub first emerged outside the den, she was killed by the dog.

BEAR League's goal is to allow interested, kind and open minded viewers to witness the sweetness and Motherly Love that Bear Mamas share with their cubs, pretty much the same kind of love, protection, tenderness that human Moms have for their little human babies


NEIGHBORHOOD NEWS



Board Meeting Minutes January 11, 2025 (Draft)

Location: Virtual meeting via Zoom

Absent: Bob Schultz

Meeting Minutes:

1. Call to Order

- Meeting called to order at 10:19am

2. Roll Call

- Roll call was taken. A quorum was present.

3. Welcome to Guests

- Larry, Ellie Beales and Greg Schultz were welcomed as guests to the meeting.
- "Greg reported that his father (Bob) will be stepping down from his Board position.". Greg expressed an interest to step in for his father on the Board. Don appointed Greg to serve on the Board until he can be voted in by TCPOA Members at the Annual meeting in August 2025.

4. Approval of Last Meeting Minutes

- Robin moved to approve the October 2024 Board meeting minutes; Dave seconded. All approved; Minutes approved.

5. Discussion / Reports

5.a President's Report/Park - Don

- Don reported the Holiday Gala in December was a success and thanked everyone who helped.
- There continues to be a shortage of volunteers for TCPOA activities and events, and Don requested Board members and other TCPOA members to increase their volunteer assistance.

5.b Treasurer's Report - Trisha

- Trisha presented financial report for the year end 2024 and Budget/Actual summaries for 2022 through 2024 and a proposed budget for 2025.
- Donations were down in 2024, but at year end TCPOA has over \$119K in checking with about \$10K in funds available after allowing for ongoing expenses and reserves.
- Dave suggested the major pier repair work can wait a year or so, but not much longer. J.J. suggested that BJ (local contractor) can help with pier repairs. Dave will reach out to BJ to get input.

- There are funds available to install remaining pavers in front of the stage at the Park in 2025.

- Minor adjustments were made to the proposed budget for 2025 including minor increases for new website maintenance and dues revenue.

- Dave made a motion to approve the 2025 budget with the minor adjustments described above. J.J. seconded the motion. The 2025 budget was unanimously approved.

- Derek requested a checking account transaction report to be generated on a regular basis. Don and Ellie agreed to help Trisha prepare a standard QuickBooks report that could respond to Derek's request.

5.c Tattler Report - Robin

- The next Tattler will be issued in mid-February. Aaron Hussmann (TCPUD's new public information representative) will provide an update for the upcoming Tahoe Cedars Water System Reconstruction Project.

5.d Membership Report - Larry

- Membership at the end of 2024 was approximately 323 members, but membership is still behind the 2023 figures. With the new website up and running TCPOA should be able to increase membership for 2025 with more effective and efficient sign-up process and communication.

- Larry will organize a membership-wide communication email in January reminding members of the membership renewal process.

5.e Buoy Field Report - Don

- The Buoy Committee (Don, Trisha, Robin) need to meet soon to address issues raised by Derek at the last Board meeting and refine the buoy rental process for 2025.

- The goal is to have the new buoy system reservation process ready to go live on **May 1, 2025**.

5.f Park Construction Report - Dave

- As discussed previously, remaining pavers will be used to create a dance surface in front of the stage in 2025.

5.g Website Discussion - Larry

- Larry reported the new website is ready to go live (except for the new buoy reservation system). The membership database is complete and the financial components are ready to launch.

6. Old Business

6.a Operating Guide - Larry

- Larry is working on a draft of the TCPOA Operating Guide designed to provide policies and procedures for operations of TCPOA.

6.b Water Project - Larry

- TCPUD is currently in the procurement process of hiring its progressive design-builder for the Tahoe Cedars Water System Reconstruction Project.
 - The recent wildfires in Los Angeles underscores the importance of having an up-to-date water system for the Tahoma community. Improving Tahoma's fire protection is one of the key objectives TCPUD has established for the Project.
 - Aaron Hussmann (TCPUD's public information representative) will be providing an update on the Project for the February issue of the Tattler.

7. New Business

7.a Board Members - Don

- More Board members are still needed to fill vacant positions. Don asked everyone put out the request in the community to fill the vacancies.

7.b Volunteer Park Committee - Don

- Don needs help managing the Park and various other TCPOA activities. The Operating Guide (described above) will include minimum expectations and dedicated time of Board members so that TCPOA activities are distributed among ALL Board members.
 - Word needs to get out to the community that more volunteers are needed to share the workload of the Association.

8. Next Board Meeting

- The next Board meeting is scheduled for Saturday March 15, 2025, at a time and location to be determined.

9. Adjournment

- Meeting was adjourned at 11:59am. (Dave motioned; Robin 2nd)

Tahoe Cedars Water System Reconstruction: An Update from the Tahoe City Public Utility District

TCPUD is making progress on this complex project. Right now, we are working on early designs, environmental permitting, and securing the funding we need. This project will involve several construction phases and should take four to five years to complete.

We plan to hire a contractor for the project in early 2025. To make things easier, we are using an approach called Progressive Design-Build. This helps us design and build faster and at a lower cost. It also lets us work closely with the contractor to reach our project goals. While we hope to start construction in 2025, we have not yet determined the project phases or locations.

TCPUD is also working on a Private Service Relocation Policy. This policy addresses properties where water mains are in backyards instead of in the public right of way. We will let affected property owners know when this policy will be reviewed by the TCPUD Board of Directors, likely in mid-2025.

Completed Improvements:

- Replaced failing water mains on 2nd Avenue.

- Installed a connection between the Tahoe Cedars water system and a nearby TCPUD water system. This connection provides a critical backup water supply.

TCPUD will continue to provide regular updates in the Tattler and post project updates at www.tcpud.org/tahoecedars.

New! Expanded Water Rate Assistance Program

More customers now qualify for TCPUD's Water Rate Assistance Program. The TCPUD board has added a second tier of rate assistance for income-eligible customers:

- Tier One: Offers a 50% water rate reduction for customers enrolled in the Liberty Utilities CARE program.
- NEW - Tier Two: Offers a 25% water rate reduction for customers who meet expanded income eligibility criteria. In 2025, eligible customers can reduce your water bill between \$26.64 to \$53.29 per month.
